For all pollutants the Applicant shall use the applicable sampling and test procedures found in the most recent edition of the Code of Federal Regulations, Title 40, Part 136 (40 CFR 136).

8. Program guidelines

In certain situations, MSD may approve the discharge of compatible hauled wastewater from generators at designated discharge locations. The hauled wastewater shall not contain any prohibited substances, materials, waters, or wastes listed in Article XV of MSD’s Rules and Regulations. MSD does not accept wastewater defined as a RCRA Hazardous Waste or from a process defined as categorical by Title 40 Code of Federal Regulations Part 403. MSD designates approved generators of wastewater hauled to MSD as Significant Industrial Users, since the wastewater has a reasonable potential to adversely affect the wastewater treatment plant operations. MSD reports information regarding Significant Industrial Users to the Ohio Environmental Protection Agency (Ohio EPA) at least annually. Generators must remit an annual permit fee. The term of the permit shall extend for a period of three years.

Generators are required to use MSD-permitted haulers for transporting wastewater to MSD’s approved hauled waste discharge location at hours of operation specified by MSD. Each waste stream must be profiled prior to permit approval and periodic monitoring may be required at the waste hauler’s expense.

Certification

Applicant agrees to comply with the terms and conditions of the Hauled Waste Generator Permit issued to the approved applicant by MSD. By general permit, *MSD Rules and Regulations* authorize the discharge of sanitary wastes originating in the District Service Area. All other wastes require special approval by the Director. Generators must submit periodic self-monitoring reports to MSD. These self-monitoring reports certify that liquid wastes hauled to MSD for disposal do not contain prohibited substances, materials, waters, or wastes such as solid waste and must not contain RCRA Hazardous Waste. Furthermore, generators are also required to maintain a disposal log of all liquid wastes discharged to the MSD. Failure to furnish the required information or furnishing incomplete or inaccurate information may result in cancellation of the permit hereby applied for and/or enforcement action as permitted under Article XXII of *MSD Rules and Regulations*.
