### MEDICAL OPERATIONS INSTRUCTION SHEET

Metropolitan Sewer District Rules and Regulations require that nonresidential wastewater discharges apply for a Wastewater Discharge Permit. Medical Operations are defined as nonresidential and may be covered by a General Permit. However, the purpose of this application is to keep an accurate record of your contact information and practices so that we may know your facility's potential for contributing wastewater to the sewer. Registration of your Medical Operation is required, free of charge. The information will be used by the Metropolitan Sewer District's Division of Industrial Waste. Failure to comply with the registration process may be a violation of Article XV of the Metropolitan Sewer District Rules and Regulations and may subject the violator to enforcement action. Below you will find instructions for completing the registration form.

1. Please print or type the Medical Operations (MO) form. The MO form can be found online at [www.msdcg.org](http://www.msdcg.org) under "Industrial User Resources".
2. The Sewer Use Customer Application must be completed along with the Medical Operations form. Answer all questions carefully. If there is doubt about the appropriate response to a question, write "unsure" or "information not available." In some cases, the questions may be answered by a simple check mark. This form may also be found under the "Industrial User Resources" heading.
3. The Facility Description section of the form asks about the nature of business operations. Please check all types of facility, the location, equipment, and fixtures that apply to your facility. Fill in all operation information about your facility.
4. The Waste Management section of the form inquires about the waste management at your facility. Waste Management includes trash/solid waste, medical waste, and other waste disposal.
5. Please refer to the FAQ (Frequently Asked Questions) section online or contact the Division of Industrial Waste at (513) 557-7000 with questions.
6. Return the completed form to the Metropolitan Sewer District. ## DEFINITIONS

- Commercial User - shall mean any and all users of the wastewater treatment system not otherwise classified.
- Industrial User - shall be any user which discharges industrial waste.
- Residential User - shall mean any single or two-family housing unit.
- Responsible Official / Duly Authorized Representative - shall for a corporation be a responsible corporate officer, or the manager of facilities having more than 250 employees or gross annual sales or expenditures exceeding \$25 million in second-quarter 1980 dollars, provided signatory authority has been assigned to the manager; for a partnership, a general partner; for a sole proprietorship, the proprietor; or a duly authorized representative of the general partner or proprietor, provided that the authorization is in writing, the party authorized has overall responsibility for operations or environmental matters, and the written authorization has been submitted to the District.
- Sewer - shall mean any pipe or conduit for conveying wastewater or drainage water.
- User - shall mean any person that discharges, causes, or permits the discharge of wastewater into a public sewer.
- Wastewater - shall mean a combination of the liquid and water-carried wastes from premises together with any groundwater, surface water, or storm water that may be present.
