## **TRAFFIC ALERT Lane Restrictions on Mill Road ~April 24 thru August 2017**

CINCINNATI – Lane restrictions will occur on Mill Road between 12005 Mill Road and the westbound lane of I-275 beginning approximately April 24 and ending in August 2017.

The project, known as Pleasant Run Central Force Main Repair, is located between 12005 Mill Road and the intersection of Mill Road and westbound I-275. As part of the project, the Metropolitan Sewer District of Greater Cincinnati (MSD) will be replacing approximately 750 linear feet of 24-inch diameter aging sewer in two different sites along Mill Road.

Construction will start at Site A near the Hazelgrove Drive and Mill Road Intersection. One lane of traffic will be maintained during working hours, but delays are possible. Mill Road will be completely open from 7 p.m. to 7 a.m. weeknights and all day on weekends unless weekend work is needed. Site A construction is anticipated to last approximately six weeks depending upon the weather.

Immediately following the completion of Site A work, the contractor will move further south to Site B located near the Mill and West Kemper roads intersection. During Site B construction, the southbound lane of Mill Road will be completely closed between W. Kemper and John Gray roads for approximately six weeks depending upon the weather. The northbound lane will remain open. Traffic from the north can detour to John Gray Road to Hamilton Avenue to West Kemper Road to Mill Road south.

Construction activities will occur primarily Monday through Friday during daylight hours, depending on the weather and the contractor's schedule. MSD's contractor is Ford Development Corporation.

In addition to traffic delays, typical construction-related disturbances such as noise, dirt and vibrations should be expected throughout the construction period. Access to homes and businesses will be maintained throughout the construction period.

We apologize for any inconveniences and will work diligently to minimize disruptions.

This project is part of Project Groundwork, MSD's multi-year plan to reduce sewer overflows into streams and rivers in Hamilton County. Project Groundwork will improve the quality of our lives through cleaner streams, improved protection of public health, and enhancement of the communities where we live, work, and play.

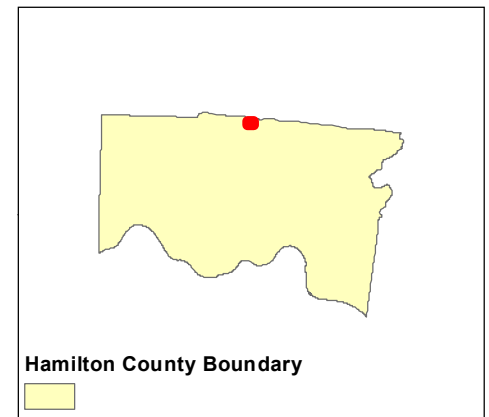

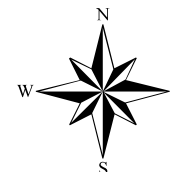
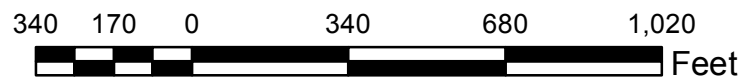


## Map Legend
