Selection Criteria			
General			
<ul style="list-style-type: none"> To count towards the advertised SBE participation goal during the proposal review process, a SBE must hold a current SBE certification from an MSD approved agency at the time of proposal review. Points may be deducted if a requested form is incomplete and/or contains inaccuracies. Scoring is at the discretion of the individual rater. 			
1. Achievement of the Advertised SBE Goal (Maximum 10 points; option for up to 2 additional points)

	The vendor's proposed certified SBE participation meets the advertised SBE participation goal. No points will be awarded if the goal is not met.	10 points	0 points
	Advertised SBE Goal Exceeded	Example	
	One additional point will be assigned for every 2% increase in proposed SBE utilization above the advertised SBE participation goal, not to exceed 2 points. Proposed SBE subconsultant(s) must provide a scope of work MSD deems necessary to the project. The additional point(s) may not be awarded if it is determined that an SBE subconsultant's scope of work is not necessary to the project and/or may be negotiated out of the final project agreement.	2% above advertised goal	1 additional point awarded

	A specific type of work / supplier must be listed for each proposed subconsultant. Vendor should ensure that the type of work / supplier listed on the form for each SBE firm matches a commodity code listed on the SBE firm's certification. Vendor may list specific commodity code(s) on the form.		
e.	Specific Subconsultant Percentage Provided	5 points	Less than 5 points
	Form must include specific numeric percentage for each proposed subconsultant in order to receive points. Does not include ambiguous language (i.e. To Be Determined or +/-).

The additional point may not be awarded if it is determined that the SBE subconsultant's scope of work is not required by the project and/or may be negotiated out of the final project scope. <u>or</u> One additional point will be assigned to an SBE vendor who, if awarded the contract, would be awarded its first Prime contract with MSD.
